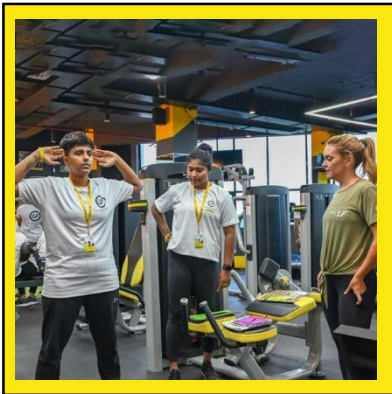

TERMS & CONDITIONS

To ensure a smooth and professional learning experience, all students enrolled in the Diploma in Personal Training programme are expected to adhere to the following academic rules and conditions:

1. Learners must join online classes from a quiet, comfortable space free of distractions.
2. Appropriate dress code and respectful behavior are mandatory at all times.
3. Mobile phones and other electronic devices not related to the session must be turned off or kept aside during class.
4. Students must enter the virtual classroom on time and remain attentive throughout the session.
5. Microphones must be muted unless otherwise instructed by the tutor.
6. It is compulsory to keep cameras turned on during live online sessions for effective interaction. Failure to comply without prior approval from the coordinator may lead to removal from class.
7. Any misconduct, distraction, or engagement in non-class activities during sessions will lead to disciplinary action by the Academy.
8. Attendance in all scheduled live theory sessions is mandatory.
9. In case of absence or expected delay, students must inform their batch coordinator at least one hour in advance and are responsible for catching up on missed content independently.
10. The full course fee includes access to E-Manuals, Practical Sessions, Learner Assessment Packs (LAP), Theory & Practical Assessments, and Certification.
11. The payment schedule must be strictly followed:
 - **First Installment** of **AED 2500** must be paid prior to the start of theory sessions to receive e-manuals and LAPs.
 - **Second Installment** of **AED 1500** must be completed before the start of offline practical sessions to be eligible for the Theory Exam and Practical Classes.
 - **Third Installment** of **AED 1775** must be paid prior to the Final Practical Exam.
12. A penalty of **AED 500** will be applicable for any missed installment due date.
13. All payments, including the initial deposit, are **non-refundable**.
14. **AED 500** penalty will be charged for changes in scheduled exam dates after issuance.
15. **AED 300** will be charged for transferring to a different practical batch.
16. Students will have a **15-day grace period** post practical classes to submit LAPs. Late submissions will incur a **AED 500** extension fee.
17. Hard copy of course manuals is available for an additional **AED 250 (optional)**.
18. Any replacement certificates requested after 24 hours of issuance will be subject to a fee of **AED 250**.
19. A penalty of **AED 150** will be charged if a student submits their LAP more than 15 days late or fails the second attempt to pass the LAP with correct answers
20. **Additional Charges:**
 - AED 350 – First Aid in CPR and AED Certification
 - AED 450 – REPS UAE License
